Privacy Notice

In the following, we would like to inform you about the processing of your personal data in the above context and inform you about your rights:

1. Controller as defined by the EU General Data Protection Regulation (GDPR): The controller as defined by the General Data Protection Regulation (GDPR) for the processing of data described here is

3. Purposes and Legal Basis of Data Processing: The legal basis for this processing of data is Article 6(1) sentence 1 letter a) GDPR. The employees' photos are taken for the purpose of publication and information on the intranet and/or on internal drives of the company.

4. Retention Period: The employees' photographs will continue to be stored after they leave the company until the respective employee has revoked their consent. This applies in particular if more than one employee can be seen in the photographs and these do not suggest that they are of a current nature.

5. Rights of the Data Subjects: As a data subject, you have the right to obtain confirmation from Interzero Holding GmbH & Co. KG (hereinafter "Controller") as to whether or not and in what form your personal data are being processed; if this is the case, you have the right to access these personal data and to the information specified in detail in Article 15 GDPR.

If you, as the data subject, do not consent to the processing of your data for the purposes described in this document for the future, you have the right to revoke your consent for the future at any time, as stated above.

As the data subject you also have the right to obtain from the Controller without undue delay the rectification of inaccurate personal data concerning you and the completion of incomplete personal data concerning you (Art. 16 GDPR).

Without prejudice to any other administrative or judicial remedy, every data subject has the right to lodge a complaint with a supervisory authority if the data subject considers that the processing of personal data relating to them infringes the GDPR (Article 77 GDPR). The data subject may exercise this right before a supervisory authority in the Member State of their residence, place of work, or the place of the alleged infringement.
